



Alan George Vitkus

May 11, 1943 - June 11, 2016

Alan Vitkus, 73, of Corvallis, Oregon, formerly of Las Vegas, Nevada, passed away Saturday evening June 11th at Camp Adair, Oregon.

He was born May 11, 1943 in Waterbury, Connecticut to Joseph and Ethel (Ottinger) Vitkus.

Alan grew up in Waterbury where he graduated from Crosby High School. He then attended the University of Connecticut where he earned a Bachelor's degree in psychology. Alan moved to Las Vegas, Nevada when he was 22. He later graduated from the University of Southern California with a Master's degree in public administration.

He was a Supervisor in the Parole and Probation Division of Clark County Juvenile Court in Las Vegas for many years and later worked as a Real Estate broker from 1979 to 1999. Alan married Linda Martens in September of 1981 in Las Vegas.

In 2000, Alan and Linda moved to Corvallis where he worked as a placement counselor for the JOBS Program through the Department of Human Services. He retired in 2008. Alan served as a child advocate through CASA of Benton County from 2000-2013. He also served as a Court Visitor, assisting the

Circuit Court in investigating the allegations contained in petitions for guardianship /conservatorship, during the period from 2002-2013.

He was an avid bicyclist who loved gardening and the outdoors. He loved his life and the people he met during his life. He knew how to be a good friend.

Alan is survived by his wife Linda Vitkus of Corvallis; brother Bob Vitkus and Bob's wife Patricia of Corvallis; many cousins; 9 nieces and nephews; and 12 great nieces and nephews.

He was preceded in death by his parents.

A memorial gathering will be held at 2:00 PM Saturday, June 18th at McHenry Funeral Home.

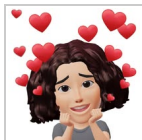

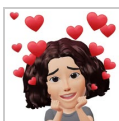
